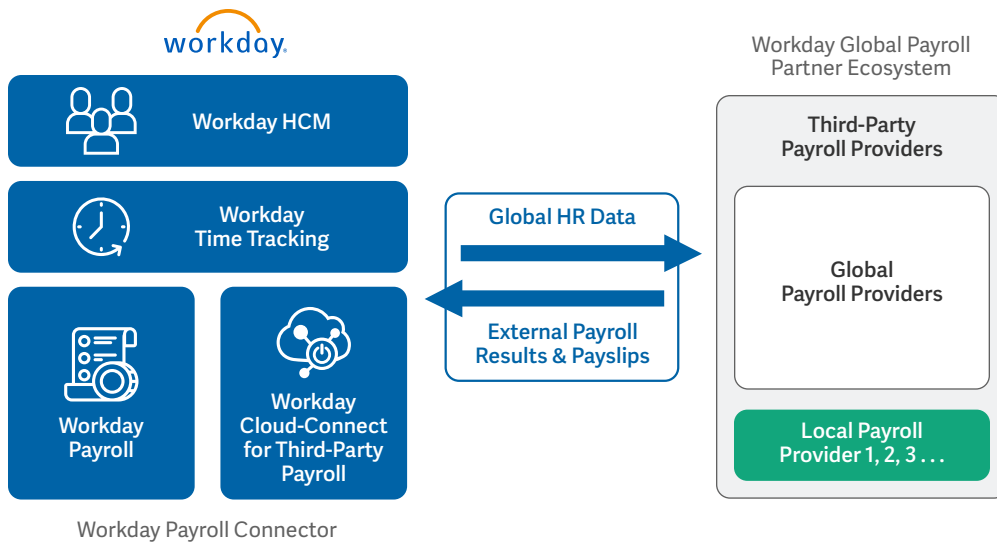
Manage globally and process locally.
